Chairman Mitchell, upon declaration of a quorum being present, opened the meeting for the transaction of business.

Public Comments on Agenda Items:

Bill Smoak of Florence, Alabama stated that he would like for the Commissioners to consider that the time frame for citizens to speak be changed from three minutes to five minutes, and that the City of Florence had a five-minute time frame. Mr. Smoak also stated that the County Commission must state the reason or purpose of the Executive Session that is scheduled later on during the Commission meeting.

Commissioner Hackworth moved, seconded by Commissioner Parker that all items listed on the regular business agenda be approved for immediate consideration. There being no discussion and upon a vote taken, motion unanimously approved. Agenda is herein recorded and made a part of these minutes.

Commissioner Garner moved, seconded by Commissioner Pettus that the minutes of the last regular meeting of the Commission be approved for recording. There being no discussion and upon a vote taken, motion unanimously approved.

Commissioner Garner moved, seconded by Commissioner Hackworth to approve a resolution that authorizes the Lauderdale County Commission to approve a grant agreement from the State Homeland Security Grant Program in the amount of twelve thousand, seven hundred and

forty-six dollars and forty-five cents. This grant will be used to purchase VHF Repeater Radio Equipment. George Grabryan, Lauderdale County EMA Director, is authorized to execute this agreement on behalf of the Lauderdale County Commission. There being no discussion and upon a vote taken, motion unanimously approved. Resolution and grant agreement is herein recorded and made part of these minutes.

Commissioner Pettus moved, seconded by Commissioner Parker to approve a resolution that authorizes the Lauderdale County Commission to change the regularly scheduled Lauderdale County Commission Work Session meeting from Monday, July 4th, 2016 at 4 p.m. to Tuesday, July 5th, 2016 at 4 p.m. due to a Federal Holiday. There being no discussion and upon a vote taken, motion unanimously approved. Resolution is herein recorded and made part of these minutes.

Commissioner Parker moved, seconded by Commissioner Pettus to approve a resolution that implements a voter file maintenance process for the Board of Registrar's Office. This requires the Lauderdale County Commission to pay for the cost of postage necessary to mail certain notices to the voters and subsequently apply for and receive reimbursement costs from the State of Alabama. The Lauderdale County Commission does hereby agree to appoint the Secretary of State to serve as its agent for the purposes of paying postage costs necessary for mailing of certain notices to voters as required by Code of Alabama 1975, section 17-4-30 and collection reimbursements for such costs from the State Election Expense Account. There being no discussion and upon a vote taken, motion unanimously approved. Resolution and agency agreement is herein recorded and made part of these minutes.

The invoiced bills were audited, allowed, and ordered to be paid upon a motion by Commissioner Hackworth and seconded by Commissioner Pettus. There being no discussion and upon a vote taken, motion unanimously approved.

Public Comment Period:

Janice Williams of 7384 Highway 72, Killen, Alabama stated that the citizens of Lauderdale County deserved to have quiet and respectful neighbors, and she wanted the Lauderdale County Commission to pass the same noise ordinances that the City of Florence had. Ms. Williams stated that barking dogs and roosters woke her up at night and really at all times of the day and night, and that she and her daughter were deprived of sleep. Ms. Williams stated that the citizens of Lauderdale County deserved the same liberties as the citizens of the City of Florence and Ms. Williams urged the Commission to pass the same noise ordinances as the City of Florence. Ms. Williams did state that her neighbor had been bitten by a dog and that there was nothing that they could do. Ms. Williams did pass out a copy of the City of Florence's noise ordinance.

Bill Smoak, a citizen of Florence stated that he wanted to know why he did not get a ruling on the Executive Session question he had asked earlier during the meeting. Mr. Smoak stated that he wanted to know what the correct answer on the purchase of the animal property was, who was buying the property, and for how much was the lease.

Chairman Mitchell stated that he would turn the meeting over to Chris Smith, Lauderdale County's Attorney. Mr. Smith state that he was the attorney for Lauderdale County and that he was stating that there was a need for an Executive Session based on pending litigation. Mr. Smith stated that the law required that a licensed attorney shall state at an open meeting the need for such an Executive Session for the Commission. Mr. Smith stated that he was requesting this for the record, at which time Mr. Smith turned the meeting back over to Chairman Mitchell. Chairman Mitchell stated that he needed a motion and a second to adjourn the meeting into an Executive Session and the Commission meeting would not reconvene, but there would be a work session after the Executive Meeting was concluded. Commissioner Pettus moved, seconded by Commissioner Garner. Chairman Mitchell then asked for a roll call vote.
